

Daycare Price List

For the 2017/18 Academic Year



Daycare fees apply to all children aged under 3 years, plus 3&4 year olds attending Goslings for more than just the Governments offer of 15 or 30 hours free childcare. If you just wish to just take up a fully funded place at Goslings only, please see the separate funding contract document instead.

Deposit:

To secure a daycare place at Goslings, please complete and return the cream registration form and childcare agreement, together with a non-refundable £150 deposit. The deposit secures your place.

The first £100 of this deposit is paid into your child's fee account, reducing your first months bill. The separate £50 administration fee, covers the cost of the settling-in visits, folders, and setting your child up on our computerised systems.

Eligible for 2yr old funding?? For part-time parents in receipt of 2yr old funding, your bill will reduce by £208/month, as the funding will pay for your first day of childcare each week. A full time, funded 2yr old, would pay £752.10/month. You can check eligibility at www.coventry.gov.uk In simple terms, 2 yr old funding is for children with a statement of SEN, families on a CAF program, in receipt of specific benefits and those with households earnings under circa. £16k per annum.

Ad-hoc and additional days are charged at £48/day, payable in advance.
